#### **LWV WBLA Nonpartisan Policy**

Each local League is strongly encouraged to have its own nonpartisan policy which they can use to inform their members, their community, candidates and other individuals who participate in public forums and events, and partner organizations. White Bear Lake Area President-Elect, Lori Soukup, along with Treasurer Liz Nordling and members Heidi Boyd, Sarah Amundson, and Susan Fuller, have developed a nonpartisan policy for our League that the Board has recently approved. It will go before the full membership this April at the Annual Meeting to be officially approved as our local League Nonpartisan Policy, and will be reconfirmed by the membership every year. Thank you to the committee members who gave their time to get the wording just right!

#### Nonpartisan policy - LWV White Bear Lake Area

At each annual meeting, LWV WBLA members will review and approve the following nonpartisan policy.

LWV WBLA is nonpartisan in both our education and advocacy. We support the informed and active participation of citizens in government. We encourage our members to be informed participants in political activity. As a nonpartisan organization, we neither oppose nor support a political party or candidate even when the office is unaffiliated with a party. We take action on selected governmental issues only after study and consensus by our members.

Board members who are candidates for political office should resign from the Board or take a leave of absence during their campaign. When members are candidates for elective office, they may mention their involvement in LWV as long as they do not infer League endorsement.

The President, Voter Service Chair, Action Chair and moderators will refrain from involvement in political campaigns during their terms of office; such involvement would include having one's name on campaign literature or social media, displaying yard signs and hosting political gatherings. Attending a precinct caucus is permitted. No League member who is highly visible in a political party, closely associated in some way with a candidate, or identified with an issue under discussion at a League sponsored event should be involved in running that event.

The League position on an issue is never stated by the League during a public candidate forum.

Co-sponsorship of voter service activities is encouraged, but can present problems of perceived bias. If LWV WBLA's name is on a project, League guidelines for non-partisanship and fairness must be agreed upon ahead of time and followed. If the group has endorsed issues or candidates before the forum, the League should not be

involved. The League wants to encourage citizen involvement and provide experienced moderators for the community. It does not want to participate in poorly conceived or executed forums. If a League member is asked to moderate for a different group, she/he must explain our nonpartisan policies to them and consider the following questions: What is the motivation of the sponsoring group? Have all candidates been invited? Are they attending? If not, why not? What are the issues in this election? What is the format? What are the ground rules? Are the candidates aware of them? Will timers and ushers for collecting questions be provided?

All voter service projects, including candidate meetings, should include a disclaimer that the League neither endorses nor opposes candidates for political office.

#### Tribute to passing League members

The White Bear Lake Area LWV recently observed the passing of two of its members.

**Nat Watkins** often came to general meetings, social events, and the North Oaks unit meetings with his wife and fellow member, Avis Watkins. Nat enjoyed the topics and the conversations and visiting with friends, members, and visitors. He was always interested in what was being discussed, and he always had a smile for everyone. Our condolences to Avis and to the extended Watkins family.

**Lillian Michael** was a +50 year member of the League of Women Voters. She continued to be passionate about voting rights, educating voters, and reforming government up until her death at age 95. At her memorial service, family members told many inspiring stories about Lil's efforts on behalf of civil rights and voting rights, mentioning the League several times. Lil made everyone feel welcome. She will be missed.

#### **LWVUS Seeks Member Support for Legislation**

League members are being asked to contact their US Senators and tell them they support SB 1880, We the People Democracy Reform Act of 2017 (Link to the bill on Congress.gov). Senators Franken and Klobuchar were co-sponsors of the bill. It was introduced on September 27, 2017 and was referred to the Senate Finance Committee, and no further action has been taken on it. The act seeks to, "reform our government, reduce the grip of special interest, and return our democracy to the American people by increasing transparency and oversight of our elections and government, reforming public financing for Presidential and Congressional elections, and requiring States to conduct Congressional redistricting through independent commissions, and for other purposes." These are all positions that LWV supports and members can advocate for under our Program For Action. To contact Sen. The precinct caucuses are Tuesday, February 6th. This is a chance for you, as a voter and League member, to attend and help to shape your political party's platform and choose delegates who will endorse candidates at party conventions. It's important to be a participant in the process, so I hope you will locate where your party will be meeting and put the meeting on your calendar.

Another event to add to your calendar is the League's Day At The Capitol, which will be Monday, March 5th. This is an opportunity to hear about the State League's advocacy work for the 2018 session, to meet with your local legislators, and to familiarize yourself with the Capitol (see the results of the recent remodeling!). 

#### **Redistricting: Insuring fair representation**

Redistricting is mandated every 10 years by the U.S. Constitution and the U.S. Supreme Court. After the official 2020 U.S. Census, all states must redraw the boundaries of their Congressional and legislative districts, consistent with one-person-one-vote.

Redistricting is one of the most important issues that will come before Minnesota's legislature in coming months; therefore, the White Bear chapter of LWVMN will host a meeting on this topic

from 7 to 9 p.m. Monday, March 19, in the White Bear Lake High School South Campus auditorium.




creating safe election districts for specific legislators or a particular political party. There is no incentive for legislators in safe districts to compromise on issues or listen to all their constituents. The

result is legislative gridlock and disenfranchisement of some citizens.

Four bills now in the House and Senate could change the redistricting procedure: Two companion bills (S.F. 36 and H.F. 314) would prohibit anyone except legislators from redrawing the boundaries; competing bills (S.F. 370 and H.F. 246), would create an independent nonpartisan citizen commission of retired

judges to advise the legislature of a fair redistricting plan. This latter bill is endorsed by the LWVMN. It leaves the final decision in the hands of the legislature, but adds input from nonpartisan sources.
